填表須知

A. 簽發條件

- (一) 額外公共巴士客運營業證的批准須視乎此等需要是否真確及其需求是否有其他交通工具足以應付。
- (二) 倘若該車輛是用作行走專綫服務,則須事先獲得運輸署批准,方可行走該專綫。
- (三) 客運營業證證明書乃簽發予以客運營業證經營的車輛。
- (四) 客運營業證證明書的有效期爲一年或與客運營業證的屆滿日期相同,兩者以日期較早者爲準。
- (五) 每輛以客運營業證經營的車輛,必須:—
 - (a) 在該車輛擋風玻璃的左面展示一張由運輸署署長指定格式的證明書;及
 - (b) 根據道路交通 (公共服務車輛) 規例第 2 附表中圖 2 所指定的形式於車輛後面展示載有客運營業證編號的字牌。
- (六) 任何人士不得駕駛或使用已領有客運營業證的車輛或容許或任令他人駕駛或使用該車輛,如該車輛:—
 - (a) 並無展示如上文第(五)段所指的證明書及字牌;
 - (b) 展示該證明書或字牌的方法與上文第(五)段所指定者不符;

APPLICATION FOR PASSENGER SERVICE LICENCE CERTIFICATE(S) — PUBLIC BUS SERVICE

NOTES FOR ATTENTION

A. CONDITIONS OF ISSUE

- (1) Inclusion of additional public bus passenger service licence is only approved where it is satisfactorily shown that the need is genuine and the demand cannot be satisfactorily met by other transport facilities.
- (2) If the vehicle is intended to run scheduled service, prior approval has to be obtained from the Transport Department.
- (3) Passenger service licence certificate(s) will be issued in respect of vehicle(s) operating under the passenger service licence.
- (4) A passenger service licence certificate is valid for one year or until the passenger service licence expires, whichever is the earlier.
- (5) Every vehicle operated under a passenger service licence shall display:
 - (a) on the left hand half of the vehicle's windscreen in a manner as to be visible from the front of the vehicle a certificate in a form specified by the Commissioner for Transport;
 - (b) at the rear of the vehicle, a plate showing the passenger service licence number in accordance with Figure No. 2 of the Second Schedule to the Road Traffic (Public Service Vehicles) Regulations.
- (6) No person shall drive or use a vehicle operated under a passenger service licence or suffer or permit such a vehicle to be driven or used, if such vehicle:
 - (a) does not display the certificate and the plate referred to in paragraph (5) above;
 - (b) displays such certificate or plate other than in the manner prescribed by paragraph (5) above;
 - (c) displays any such certificate or plate purporting to be a certificate or plate referred to in paragraph (5) that:
 - (i) is damaged, altered or defaced;
 - (ii) does not relate to a passenger service licence concurrently in force in respect of the vehicle; or
 - (iii) does not relate to the vehicle:
 - displays a certificate referred to in paragraph (5) that is invalid.
- (7) The fee for each passenger service licence certificate is \$160.
- (8) Subject to prior approval given by the Commissioner for Transport, public buses may carry standing passengers.

B. COMPLETION OF FORMS

In the case of a limited company, the declaration should be signed by the person authorized by the company.

C. SUBMISSION OF APPLICATIONS

All completed applications should be submitted either in person, by agent or by registered post to Public Vehicles Unit of Transport Department at 3/F., United Centre, 95 Queensway, Hong Kong.

D. AMENDMENT

The Commissioner for Transport should be notified of any change in particulars immediately.

E. SUPPORTING DOCUMENTS

The following documents should be forwarded at the time of submission of the application form: —

- (a) Valid Business Registration Certificate (certified true copy);
- (b) Documentary evidence to show that maintenance and service facilities are provided by appointed garage/motor car company;
- (c) Approval letter issued by the Transport Department if the vehicle is to run scheduled service (copy only); and
- (d) Other relevant documents/information in support of the application not mentioned above.
