Important Notice

Verification of E-contact Means

Legal Requirements of the Transfer of Ownership of a Vehicle (Except Taxi)

In accordance with the law, the registered owner ('the existing owner') shall submit the duplicate of the "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" (i.e. page 3 of the form TD25), completed and duly signed by the existing owner and the new owner, to the Vehicle Records Office of this Department within 72 hours after the transfer of the ownership of the vehicle. The new owner shall submit the original of the "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" (i.e. page 1 of the form TD25), completed and duly signed by the existing owner and the new owner, to a Licensing Office of this Department, together with the required documents and fee within 72 hours after the transfer of the ownership of the vehicle, in order to complete the transfer of vehicle ownership procedures. The existing owner should ensure that the new owner submit the original "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" to the Transport Department in order to complete the transfer of vehicle ownership procedures within 72 hours after the vehicle is transferred to the new owner, otherwise, the transfer of ownership is incomplete. Before the transfer of vehicle ownership procedures are completed, as the vehicle is still registered under the name of the existing owner, the existing owner needs to continue to take up all legal liabilities incurred by that vehicle.

Signature and Chop on Vehicle Registration Document (VRD)

The VRD <u>has to</u> contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD <u>has to contain</u> the signature of an authorized representative together with a company/organization chop and the chop on the application form <u>must be identical</u> with that on the VRD, otherwise this department will <u>not</u> process the licensing application.

Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months <u>has to</u> be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [Please refer to the list of acceptable proof of address]

Change of Address or E-contact Means

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address or e-contact means. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address (if applicable) through GovHK, by submitting the specified form ("Change of Personal Particulars or Vehicle Particulars") or in writing.

The registered owner must display the new vehicle licence on the vehicle and ensure the licence is valid for using the vehicle on road.
- (4) The Commissioner for Transport may, in processing licensing application, require the applicant to produce proof of his/her present address, and may suspend the processing of the
- application until the production of such proof. Applicants please bring along your proof of present address for presentation as and when requested by officers of licensing offices. Please be advised that payment of additional fee does not mean that the vehicle will be licensed for the period for which such fee is charged and that any new licence granted under such circumstances will only start from the date of issue.
- (10)The Commissioner for Transport is not empowered to issue any vehicle licence to you if there are any outstanding court orders directing the Commissioner for Transport to refuse to issue the said licence to you.
- If applicant has used cheque to settle payment of outstanding traffic fines, application for issue/renewal of driving/vehicle licence and/or transfer of vehicle ownership would only (11)be processed after 7 working days from the date of cheque payment.
- Any person (including the registered vehicle owner and driver) has the responsibility of ensuring the presence of a valid third party risks insurance policy for the vehicle concerned whilst using it on roads. Person who contravenes such requirement commits an offence and is liable to a fine of \$10,000 and imprisonment for 12 months, and will also be disqualified from holding or obtaining a driving licence (for a period of 12 months to 3 years). The Commissioner for Transport may refuse to license the vehicle concerned or cancel the vehicle licence concerned.
- This Department shall not process any licensing application from a dissolved company. You may search for the status of a company that is registered in Hong Kong at the (13)Companies Registry's Cyber Search Centre (www.icris.cr.gov.hk) to ensure that the related company is still on the register of companies of the Companies Registry.
