Required Documents

- 1. Original or photocopy of your identity document;
- 2. Original or photocopy of your valid Private Driving Instructor's licence; and
- 3. One recent photograph ,with plain background, size $40\text{mm}(\mathbf{W}) \times 50\text{mm}(\mathbf{H})$ taken full face without headwear.

Place of Submission

- 4. You can submit your application by post, in person or by agent to Transport Department Driving Test Appointment Office at 2/F., Cheung Sha Wan Government Offices, 303 Cheung Sha Wan Road, Kowloon.
- 5. If the application is submitted by an agent, the agent is also required to produce his/her own original identity document for record purpose.

Issue of Private Driving Instructor Identity Plate

6. The Private Driving Instructor Identity Plate will be issued to the applicant after processing the application. If the application is made by post, the Transport Department will contact the applicant by using his/her correspondence address available in the Vehicles and Drivers Licensing Integrated Data System.
