# PERSONAL INFORMATION COLLECTION STATEMENT

### Purposes of Collection

1. The personal data provided by means of this form will be used by Transport Department for the following purposes:

# Classes of Transferees

- 3. The personal data you provided by means of this form may be disclosed to:
  - (a) other government departments, bureaux and relevant organizations for the purposes mentioned in paragraph 1 above; and
  - (b) any person for the purpose mentioned in paragraph 1 above.

### **Access to Personal Data**

4. You have a right of access and correction with respect to personal data as provided for in sections 18 and 22 and principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Cap. 486). Your right of access includes the right to obtain a copy of your personal data provided by this form.
